City Of New Virginia Council Meeting Minutes -

The Council met in regular session on Monday May 1st, 2023, at 7:00 p.m. for the May council meeting.

The meeting was called to order by Mayor Huston with Council Members Galivan, Taylor, and Truman, present. Absent Nelson.

Galivan moved, seconded by Taylor to re-instate Justin Strange as a Councilmember. A roll call vote was taken: 3 ayes, 0 nays. Motion carried.

Minutes from the April regular meeting and Treasurer's Report were approved.

Old business discussed: No old business to discuss.

Citizen Input:Kim Kirkpatrick was present to get information about the proposed chain link fence extension on the south side of GAMP Park. Kim inquired if the trees in the old fence line were going to be taken out. The Council advised that the new fence extension would be set back to the north of the old fence line approximately six feet to give enough room for a mower to mow a strip on the south side of the new fence. The trees in the old fence line will remain and not be removed.

Water Utilities discussed: No new information or items to discuss.

Fire Department Business: The possible need for ordering new decal numbers for the fire trucks and ambulance was discussed. Warren County is considering following the National Incident Management System (NIMS) which requires renumbering emergency response vehicles. Price quotes for decal numbers will be requested from Iowa Prison Industries.

Law Enforcement: The report summary from the Sheriff's Office for the month of April was reviewed. Deputies received or initiated 22 calls for service during the month. Officers spent in excess of 45 hours in the city for the month. Officers patrolled in excess of 239 miles within the city limits for the month. There were two citations and/or warnings written for traffic violations that occurred within the City of New Virginia proper.

Warren County Sheriff Joe Carico was present to discuss some items. Carico inquired if the Council was ok with door checks all going on one call for service instead of each individual door check generating a call for service. The Council agreed to one call of service for all door checks. Carico was advised the Council likes the way Deputies are providing service for New Virginia. Old Settlers patrol will be the same as it has been in the past. There will be patrol scheduled for the June and September truck pulls. Fraud on a City credit card from an outside source was discussed. A detective will file a report regarding this issue.

Bids for extending the chain link fence on the south side of GAMP Park were reviewed and discussed. Three bids were received: Central Iowa Fencing \$17873.00; American Fence Company \$13724.00; Clanton Creek Fence & Gate \$12789.00. After thorough discussion, Truman moved, seconded by Strange to approve and accept the Clanton Creek Fence & Gate price quote of \$12789.00 to extend the chain link fence on the south side of GAMP Park. A roll call vote was taken: 4 ayes, 0 nays. Motion carried.

There was only one bid received for the 2023 mowing season. Strange moved, seconded by Taylor to accept and approve the mowing bid of R & R Mowing Services for the 2023 mowing season: mowing Lions Park, Old Settlers Park, fire station, library, Hen House, welcome signs, City right of way southeast corner of Broadway & Border Street at \$425.00/month. GAMP Park east half at \$425.00/month; west half of GAMP Park at \$300.00/month. A roll call vote was taken: 4 ayes, 0 nays. Motion carried.

Street projects for this summer/fall were discussed.

The current city budget and fund balances were reviewed. There will not need to be any budget amendments for the 2022-23 fiscal year budget.

The GAMP sign is done. Installation of the sign will try to be done by graduation time.

The account balance is \$4,782.20. The kite flying day turned out well. The Committee will look at changing this activity to a May date.


Putting up the banners before Memorial Day Weekend was discussed.

KAREN'S KORNER

The New Virginia Garden Club was formed in 1932, and many local women have enjoyed the regular gathering of women interested in gardening. As stated in the Club's Constitution: The object of this organization shall be the encouragement of amateur gardening, the study and protection of birds and wild life, the encouragement of shade tree planting, the improvement of the parks and lawns of the town, the exchange of seeds and plants among members, mutual helpfulness in the discussion of gardening methods through a question and answer service and the exchange of ideas in meetings. Some members were more avid gardeners than others, and Karen Taylor was a member who liked working with flowers and didn't mind "getting her hands dirty."

The small flower bed in the southwest corner of Old Settlers Park has offered a bright spot of color for many years. The New Virginia Garden Club took the responsibility to maintain it, and for many years, Karen Taylor was one of the persons who tended it and watered it. By 2021, the timbers on the borders of the flower bed were deteriorating and were in need of replacement. Member Cindy Miller was instrumental in seeing this need, and the Garden Club took on the project. Karen passed away on June 17, 2021. The Club decided to dedicate the flower bed to Karen and named it Karen's Korner. Cindy found bricks for the two tiers of borders, and the Garden Club paid for them. Kerry Johnson and Kim McWilliams did the design and construction of the flower bed. Bailey Farms donated the soil. The plants were removed during the renovation project and then were replanted, along with some new plants.

Funding for the project was accomplished by selling hanging baskets of flowers and having a donation bucket on the May 7th garage sale day. The New Virginia Garden Club made a donation, and a generous donation was received from Red Taylor, Karen's husband. Sue Stills wrote a poem for a sign for the Korner, Kathleen Trail of Crown Trophy in Grimes, IA, engraved the sign, and DSI Fabrication in New Virginia made the steel backing and support legs for the sign that is now at the flower bed. DSI installed the sign on November 7, 2022. The birdhouse garden ornament was originally painted by Karen. This is another town project that was made possible by the generosity (money and muscle) of this community. The Garden Club members hope that Karen's Korner will delight all who see it and that the memory of a good friend and willing helper will be kept alive.

- · Welcome Center: Mary Seibert was present. The Chamber of Commerce will purchase a security gate for the Welcome Center to secure the area they use. Mary wanted to thank all those that volunteered at the Welcome Center. The Council agreed that any old damaged chairs at the Welcome Center should be disposed of. ·Old Settlers: Cooking up Some Fun will take place July 14th and 15th.

Ordinance 227 Amending the Code of Ordinance by Amending Provision Pertaining to the Sewer Service Charge, 2nd and Possible Final Reading: Second reading for the sewer rate increase starting July 1st. Motion by Megan Allison/Lois Stanley to approve the second reading of Ordinance 227 as the final reading. R/C vote was unanimous. Ordinance 227 will be in effect starting July 1, 2023.

CITY OF ST CHARLES

For Frank Pierce, his reign ended as it began, in violence and strange fortune. In 1891, Frank Pierce was very well off. He not only made money by extorting businesses and placing fines on the guilty and innocent, but Pierce, also, ran a garbage collection business. There were no official city garbage collectors, so everything was done through private businesses called scavenger agencies. These collectors not only picked up the debris, but, also, went through it for items to repair and resale. Still, the garbage collected and sorted must go somewhere, so a great amount of collected garbage was illegally dumped into the Raccoon River or on private and public lands. These foul and disease carrying "dumpings" became so bad that towns and cities asked landowners to use their lands for garbage. These private dumps charged the city, and the scavengers paid fees to put garbage there. But, due to the scavenger's attempts to illegally dump rather than pay a fee, Des Moines policemen were asked to send constables to monitor these dumps and help control these known scavengers that were troublesome like Frank Pierce. Edward H. Wishart was one of these constables. A veteran of the 2nd Iowa Infantry during the Civil War, he fought as a private through the entire war with this regiment, surviving Fort Donaldson, Shiloh, Corinth and Iuka, Town Creek, Resaca, Rome Crossroads, Kennesaw Mountain, Atlanta, Jonesboro, Ogechee River, the March to the Sea, and the Carolina Campaign.

Past fifty years of age, Wishart still needed a paycheck, so he joined the Des Moines Police. On June 30, 1891, Edward H. Wishart was guarding the city's crematory on West 9th Street. For a time, Pierce and his scavengers were dumping their materials on the land of Mr. Hubble, which was managed by Augustus Becker. Mr. Becker charged scavengers to dump on Hubble's land and declared that Pierce to stop paying for the privilege. However, Pierce declared that Becker simply did not want the business anymore, as he was mad at the mayor with whom Pierce had his contract. Either way, Becker built a sturdy fence around the land which Pierce simply broke through declaring that this land was the only place the city would allow him to dump. Becker informed Frank Pierce that the next time they tore down his fence, they should bring a coffin for themselves and that he would ask constable Wishart to monitor the land and crematory. Pierce, from witness records, angrily retorted he would kill Becker and Wishart if they interfered with his business.

On the afternoon of June 30, Pierce arrived and was met by Wishart who informed them they were not going to tear down a private citizen's fence to dump their cesspool waste. Pierce ordered his crew to dig holes in the crematory land and dump the materials from the cesspools into those. Wishart, with his police star on his left breast pocket, informed Pierce that this was not going to happen as it was against city regulations. Pierce became belligerent, and Wishart informed Frank Pierce that he was under arrest. Pierce jumped from his buggy with a cocked pistol in his hand, pointed at Wishart's head screaming that it was Wishart who was under arrest. By a dark comic turn of events, as both men were constables, both were arresting the other, but neither was willing to be arrested. As Wishart pulled his own pistol, Pierce shot him in the arm and stomach where the bullet lodged in the spine. Wishart died that night declaring that "Frank Pierce said he would kill me and has." Because of a large lynch mob that called for the blood of Pierce, his trial was moved from Des Moines to Indianola that summer. Frank Pierce was not put on trial for Wishart's murder until the spring of 1892. Even then, while on trial, Pierce claimed he fired in self-defense while Wishart's deathbed report said it was not. At the trial, none of the witnesses' stories matched the others. Even the reports of four police officers who were nearby or involved, did not collaborate each other. The trial for murder was lowered to manslaughter, and Pierce was sentenced to four years in the state penitentiary. Though the verdict was passed down to Pierce in 1892, he would not be incarcerated until 1894 and went freely about after paying a \$500 bond.

Either through connections or because of good behavior, Governor Francis M. Drake pardoned Frank Pierce and released him from the penitentiary in November 1896. By January 1897, Pierce had his wife and children, who were staying with her family in St. Charles, join him, and he was seen going about Warren and Madison Counties asking for signatures to demand the governor reimburse Pierce his \$500 bond fee for the trial in 1892.



In Years Past: May 6th, 1937 The German airship Hindenburg burst into flames as it neared Lakehurst, New Jersey following a transatlantic voyage. Thirty six of the 97 passengers and crew were killed. The inferno was caught on film and also witnessed by a commentator who broke down amid the emotional impact and exclaimed "Oh the humanity."

"Sometimes it's nice to live an unhurried life. Most of the time after I've made a trip to "The City" (a.k.a. Des Moines), I can just feel the tension and stress from the rushed atmosphere that is typical of most metropolitan areas. It's nice to have 20+ miles of interstate to begin to wind down, but I never truly can breathe a sigh of relief until I hit the New Virginia city limits. We have lived in the smallest of towns (population 139) and the biggest of cities (million +). There are tremendous advantages to either extreme, but there are equally as many trade-offs. However, when I pull around the curve coming into New Virginia, I feel such a beautiful peace that all of that stress from my trip just melts away. Often I will say, "I'm so glad to be back home." I really cherish this beautiful small-town life. Of course, we have our moments where we have stress and must move at a faster pace, especially around the ministry on Mondays. But living an unhurried life is truly a choice, even on a Monday at Jesus' Right Hand.

Jesus gave us this example with the way He lived His life. In the Book of John, Chapter 11, Jesus received word that his good friend, Lazarus, had become critically ill. However, instead of jumping up and running to where his friend lay ill, Jesus chose to stay where He was for two more days. Now Jesus was at least a day's journey away from his dear friend. When you take into account that He didn't actually hear about Lazarus until the next day from the messenger that Martha and Mary sent with the news. To put it in perspective, they sent word to Jesus, let's say on Monday, and Jesus didn't arrive on the scene until some time on Saturday. He had good reason to wait, and I'm sure that His reasons were multi-layered and much deeper spiritually than our minds can comprehend. But the foundational truth of this story is that Jesus lived an unhurried life, fully trusting in God's timing and direction, refusing to bow to outside pressure.

Another example of Jesus' unhurried life is the story of Jairus' daughter in the Book of Mark, Chapter 5. He arrived at the other shore of the lake, and a synagogue leader named Jairus came to him and pleaded for Jesus to come with him because his daughter was dying. There was a huge crowd of people, and as they were trying to make their way through the crowd to get to Jairus' home, a woman with an issue of blood touched the hem of His garment. He stopped suddenly to find out who had touched Him. Why did He stop? Did He feel the woman's need was greater than Jairus' need? Again, His reasons were much deeper than we can comprehend with our minds, but I don't believe Jesus was choosing one over the other. It took the woman an extraordinary amount of courage to even be in that crowd, let alone touch the hem of His garment. The law in that day prohibited her from touching any person when she had this condition. But Jesus stopped. The woman was healed at that moment. And as He was still talking to her, word came that Jairus' daughter had died. But even then, Jesus didn't succumb to the pressure. He reassured Jairus, and they continued their journey. After He had arrived at the bedside of the dead girl, Jesus cleared the room of all the mourners. He simply took her by the hand, spoke a few words to her, and she arose.

Jesus made a choice to be unhurried. And as much as we argue otherwise, we have a choice. Do we choose to leave slightly early for work to account for any traffic delays, or do we choose to drive well over the posted speed limit because we cut our travel time down to the minute? Do we try to cram as much as possible into each day and fall into bed at night, aching and unable to sleep? Our decision-making process gets blurred when

we are stressed. We don't think clearly, and often times we rush into a choice that we later regret. I've been guilty of quieting hungry and cranky kids with something quick and fast before supper, only to find out they don't want to eat their supper when it's ready. What happens when we find our lives too busy to spend some quiet time with God? I can't even imagine how life would begin to unravel when that happens.

We have it good here in the Tri-County area. This is coming from a small-town girl who has lived in the concrete jungle and also out on the gravel. Small town life is the perfect balance, and even though we have to travel a distance for almost everything, we have the assurance that we can soon return back home and breathe a huge, stress-relieving breath of Tri-County air. It sounds kind of sappy, but that's my story, and I'm sticking to it. As for all of us here at Jesus' Right Hand, please know that we are here for you, whether it's with a hug, a kind word or a time of prayer. No hurry, no stress. Just like Jesus. Be encouraged with this word today, and be blessed in all that you do.

SCRIBBLINGS FROM SUE

In 1853, the Gadsden Purchase brought a portion of present-day southern Arizona and southern New Mexico under U.S. control. Centuries earlier, however, Native Americans were living in the area, and there are many reservations in Arizona today. Reminders of their heritage are evident in national monuments, tribal parks and historic sites that preserve their ancient dwellings, customs and crafts. Arizona's nickname is the Grand Canyon State. We drove to the Grand Canyon National Park April 14th with our 28-year-old grandson Josh and his lovely fiancée Mary who live in Philadelphia. It is about a four-hour drive from our house to the Canyon. Grand Canyon Village, at the South Rim of the Canyon, is heavily built up with hotels, lodges, cabins, shops and restaurants, and the nearby Southern Entrance Station, the most popular entrance, can be so crowded that a two-hour wait to enter is not uncommon.

In preparation for the trip, we found that the Village hotels were already booked and outrageously expensive. We wisely chose to drive to the little town of Cameron (about 18 square miles, population about 872), on the Navajo Nation Reservation. It is east of the Canyon, about a three- and one-half-hour drive, 222 miles from our house. We stayed at the Cameron Trading Post and Lodge which also had a large restaurant and a "just as large" gift shop filled with Native American crafts. I held myself to buying just one pair of turquoise earrings. The Trading Post has been owned and operated by the Richardson family of Indian traders since 1916, and today, it is owned by the people who work there. The view from our rooms was the Cameron Suspension Bridge over the Little Colorado River Gorge. The Navajo Nation honors Daylight Saving Time, which the rest of Arizona does not, so sometimes it was confusing to know just what time it was.

Driving west from Cameron, we entered the Park at the East Entrance Station – and we were the only visitors entering on both days that we were there! The guard at the gate remembered us on the second day! Our Senior Pass for the National Parks saved us the \$35 entrance fee each day. The 25-mile Desert View Drive from the East Entrance to Grand Canyon Village wound through a ponderosa pine forest and featured several viewpoints along the way. So we had our first views of the Canyon that was carved by the Colorado River over millennia. The Canyon is 277 miles long and a mile deep and features buttes, mesas, cliffs and side canyons. As the raven flies, it is 10 miles from the South Rim Village to the North Rim lodge. The rock layers at the bottom near the Colorado River date back some two billion years. There are a number of hiking trails to the bottom of the Canyon, or you can ride a mule to the bottom. There are Pink Jeep tours at ground level, as well as airplane and helicopter tours, and a small Yavapai Geology Museum. Josh and Mary did a little hiking, but we oldsters just enjoyed the view of this truly remarkable geologic wonder that is visited by six million visitors a year! (Source: AAA Tour Book)

We received a "Flat Stanley" request from our son John's first-grade granddaughter MacKenzie and her teacher in Southampton, PA. So Flat Stanley enjoyed learning about Arizona through postcards, being photographed with various citrus fruits, sitting on a blooming oleander bush and a blooming prickly pear cactus, and of course, going to the Grand Canyon.

Our son James from New York City visited us April 23-29 and experienced an environment and neighborhood quite different from his on W. 80th Street in Manhattan. Since he doesn't drive and could not help with the driving, and since we had just been to the Grand Canyon, unfortunately, we did not take him there. We did, however, drive south toward Tucson to the Saguaro National Park in the Sonoran Desert where we saw fantastic rock formations, a variety of desert vegetation and millions of saguaro (pronounced suh wah row) cacti. These are the cacti that grow "arms" and thus take on somewhat humanlike shapes. The saguaro grows only in southern Arizona, in California along the Colorado River and in the northern Mexican state of Sonora. It can live more than 200 years, attaining heights of 30 to 40 feet. The cactus does not develop its "arms" until it is 50 to 70 years old. Its blossom, the Arizona state flower, appears in May and June (we saw many in bloom and many with buds). Native Americans use its fruit for food and as a beverage base. (Source: AAA Tour Book) We enjoyed seeing many other cacti in bloom as we drove through the Park.

Springtime is beautiful here in Arizona, with many flowering bushes, trees and cacti and bright green leaves on many of the trees. Most trees and bushes stay green all year round. We had a small "heat wave" recently and had our first over 100° day in April, needing our A/C in the house and definitely in the car. Just a small taste of what is to come in the summer!

Iowa Youth Institute by Kyla Schumacher

During my second semester of Composition II, the class was introduced to a new opportunity. We had the choice to complete a paper for the World Food Prize. Students who chose to write for the Global Food Challenge would focus all their papers on the same country. I decided to take the opportunity to learn about a global issue and how to create a solution.

I picked an unfamiliar country in central Africa. Niger is a landlocked, severely hot country, and most of Niger's land is filled with desert plains and dunes. The unbearable heat becomes a challenge when women have limited access to satisfactory food quality for their families. My focus was to talk about education in Niger, especially when it comes to women needing an education. Nigerien women have a lack of education which prevents them from providing for their families. The lack of education in Niger is resulting in healthcare risks, malnutrition, and a lack of women's rights.

After writing my paper, I wasn't certain that I would get accepted. Weeks went by, and I received an email about the Iowa Youth Institute. The email was an invitation to come and present my paper to experts at Iowa State University. All I had to do was prepare a three-minute speech in advance.

On April 24, Mrs. Dentlinger drove Emma Leih and me to Iowa State University. After the Welcome and Recognition, we were split up into small groups. One of my experts was Madeline Schultz, the Women in Ag Program Manager, as well as the other expert in our group, Ellen Lupkes. After my presentation, the experts and students had a conversation about all the essays. One student mentioned infrastructure in her essay, and the experts wanted us to find a connection within our essays. I talked about how a possible solution could be building roads, so there's better road access in Niger. Many areas are not safe to travel without roads, and it's hard for anyone outside of Niger's capital to get there. That means if someone needed to access hospitals, they wouldn't be able to. We had a wonderful discussion about all our solutions and even the disadvantages of each of ours. Once we had finished our speech, we were officially Borlaug Scholars with a \$1,000 scholarship for Iowa State!

Something to keep in consideration is that solutions that may work in the United States may not work in another country. There are so many different cultures and religions globally that may affect how that country functions. One of the points I mentioned was that Niger's main religion is Islam. Even though many Nigeriens believe it is God's command to have many children, it is just as important to be able to provide for all of them adequately. The main issue occurring is a lack of women's rights, primarily in education and healthcare. The good news is that within Islam, education is a divine command for both men and women. This point made from their religion is very important because it allows others globally to understand more about how to help them using knowledge about their religion and lifestyle. If what they believe from their holy book, the Quran, says women should have the opportunity to have an education, Nigeriens need to uphold this value.

As a United States citizen, I have had the opportunity to learn from a young age. I have been reading for almost a decade and a half. I have been writing for almost as long. I was raised in a family with enough income to send me to school, feed me, and provide other basic needs. These are the bare minimum a parent should be able to provide to a child. Children should be in school learning how to read and write and developing social skills. Unfortunately, in Niger and many countries with poverty, children do not have access to basic needs such as high food quality, water, access to school, money for education, money for a home, and even basic sanitation needs. I doubt many of us here could go one day without any of these basic needs, let alone without the things we want, such as our phone, television, computer, or car. None of us would be able to do our jobs or continue in our education if we didn't learn to read and write first. This is why it's so important to advocate and find solutions to end these worldly issues because we have the privilege to do so.

I advise students taking Composition II next year to complete the paper for the Global Food Challenge. There are so many career opportunities and choices to explore even during the Iowa Youth Institute. The following list contains some of the majors you can explore relating to The College of Agriculture and Life Sciences: Agriculture and Life Sciences Education; Agricultural Business; Agricultural Communication; Agricultural Systems Technology; Agronomy; Animal Science;

Animal Ecology; Biochemistry; Biology; Nutritional Science; and Environmental Science. The Iowa Youth Institute allows you to learn from professionals in agricultural positions and people who have traveled outside of the country. It's a wonderful time to engage with others while conversing about worldly issues as a collective group.
