"It's the most wonderful time of the year!" During the weeks leading up to Christmas, much of the world takes on a magical glow, people seem merrier and even winter somehow feels cozy. Nearly everyone thinks about Christmas well before the day. Whether you are a young child writing a letter to Santa Claus, a parent buying gifts for your family and friends, a college student anticipating a holiday break back home, or a liturgy coordinator planning the décor and liturgy for the Christmas service, we are all very busy during December. Hopefully, we all anticipate a joyous remembrance of the birth of the Christ Child and plan to repeat our own family Christmas traditions, or maybe we plan to make new traditions.

Whether you are celebrating a religious festival like Christmas or Hanukkah, you are sure to have your own selection of rituals or customs. All across America, we most likely will find Christmas trees in homes, decorated with baubles that evoke memories, possibly with new ornaments to replace the ones that the baby or the cat found a little too interesting. It is a joy to drive through our neighborhoods, marveling at the multicolored lights that turn ordinary properties into sparkling places of beauty. Many families have the tradition of baking Christmas cookies for sharing and for enjoying at home. We enjoy hearing Christmas carols and attending Christmas pageants and musical performances. Many of us send Christmas cards to our family and friends. Indeed, sometimes the annual card is the only communication we have with some people, and I believe it is a way to let them know that they still matter in our lives. How about those Christmas movies? Some still evoke a tear or a "laugh out loud," no matter how many times we have seen them. We look forward to sharing a special meal with our family and friends.

Christmas traditions vary around the world. Here are several that I found interesting. Christmas traditions have been evolving for over 2,000 years, but until the beginning of the 19th century, the festive season remained a low-key affair in England. By the time Charles Dickens published his seasonal masterpiece A Christmas Carol in 1843, Christmas celebrations would have looked familiar to us with turkeys, charity, carols and decorations. Queen Victoria's German-born husband, Prince Albert, knew trees were a tradition of the season, and he may have been influential in bringing trees into homes, decorated with candles and homemade decorations. The Victorians expanded their decorations to include wreaths, ivy ribbons and mistletoe balls. By the 1880's, decorations were being mass produced. Although children often wrote messages to their family during the season, it was not until civil servant, Henry Cole, commissioned an artist to design a card for sale in 1843 that Christmas cards were first seen. At first expensive, advances in technology made printing the cards cheaper, and after the halfpenny postage rate was introduced in 1870, the Christmas card industry quickly took off.

One may view the most popular Christmas tradition, that of gift-giving, as having its roots in the gifts of gold, frankincense and myrrh that the Three Wise Men, or Magi or kings, presented to the baby Jesus in the manger. It is generally thought the Magi came from Asia, Europe and Ethiopia. Many Ethiopians, however, believe that all three were Ethiopian. That country follows the Julian calendar which means they celebrate Christmas on January 7. People dress in white, with most wearing the traditional netela, a thin white cotton scarf with brightly colored stripes across the ends. It is draped like a shawl or toga and looks very kingly.

Here is more information about decorating fir trees. Pagan Europeans would bring a fir tree into the home during the winter solstice. Tree worship was common, and they would also decorate a living tree outdoors with candles and ornaments symbolizing the sun, moon and stars on the tree of life. In Scandinavia, people decorated their homes and barns with greenery for the New Year to ward off evil. Greenery also helped Europeans visualize the spring to come. It is not known exactly when Christians began to use fir trees as Christmas trees, but the cities of Talinn in Estonia and Riga in

Latvia lay claim to the first documented use of a public tree at Christmas and New Year celebrations.

Advent, which derives from the Latin word adventus, meaning "coming," is the period beginning four Sundays before Christmas. In the 19th century, German Protestants counted down the days to Christmas by marking 24 chalk lines on a door and rubbing one off every day in December. Paper Advent calendars became popular in Germany in the early 20th century. Gerhard Lang is thought to have been the first to mass-produce them, inspired by one his mother made for him.

Poinsettias seem to be synonymous with Christmas. They bloom in the winter and are indigenous to central America, specifically to southern Mexico. A Mexican legend tells of a girl who had nothing but weeds to offer the baby Jesus at a Christmas Eve service. As she did so, they burst into bright red flowers, Ever since then, the flowers whose leaves are shaped like the star of Bethlehem, have been known as the Flores de Noche Buena, or Flowers of the Holy Night.

On December 8, Colombia honors Mary, the mother of Jesus, and the Feast of the Immaculate Conception (meaning Mary was born without original sin) with a celebration called Night of the Little Candles. Colombians light up their homes and streets with millions of white and colored candles in patterned paper lanterns. In the United States, we see a similar tradition in the luminaria lining our neighborhood walkways, each consisting of a lighted candle or tealight in an open, sand-filled paper bag.

Many theologians believe the tradition known as midnight Mass originated with pilgrims to what is now Israel. In the late 4th century, a pilgrim from Rome joined a group of Christians in a vigil in Bethlehem on the night of January 5, Christmas Eve in the Eastern tradition. The vigil was followed by a torchlight procession to Jerusalem, culminating with a dawn gathering. When the Basilica of Santa Maria Maggiore was built in the 5th century, Pope Sixtus III introduced midnight Mass on Christmas Eve in the chapel, a tradition that has since spread to many Christian countries worldwide.

One of the most unorthodox Christmas Eve traditions can be found in Norway, where people hide their brooms. This tradition dates back centuries to when people believed that witches and evil spirits came out on Christmas Eve looking for brooms on which to ride. One of the best Italian Christmas traditions is that they celebrate for much longer, from December 8 until January 6, the 12th day of Christmas, known as the Epiphany when the Magi arrived at the manger in Bethlehem. Traditionally, Italians eat fish on Christmas Eve, rather than meat. Those who live near Rome may visit the Vatican for midnight Mass with the Pope, televised in St. Peter's Square. In addition to Santa's bringing gifts on Christmas, on January 6, la Befana, "The Good Witch," visits, filling stockings with eandy for the good children and coal for the naughty children.

So Christmas traditions vary around the world. Many are familiar to us Americans, and it is interesting to learn of others. Whatever traditions you and your family enjoy at the Christmas season, may they bring joy and comfort to you, and may they be kept alive in the coming generations.

# City Of New Virginia Council Meeting Minutes December 4 th , 2023

The Council met in regular session on Monday December 4th, 2023, at 7:00 p.m. for the December council meeting. The meeting was called to order by Mayor Huston with Council Members Galivan, Nelson, Strange, Taylor and Truman present. Strange arrived at the start of agenda item number 5 – law enforcement. Minutes from the November meeting and Treasurer's Report were approved.

**Old Business Discussed:** Street repair in the 800 block of East Street has been completed. Paperwork for detailing the tree removal along North Street continues to be worked on. **Citizen Input:** Now that the Christmas lights are on in Old Settlers Park, the Park lights need to be turned off. Also, the Christmas light across the street from the fire station is not working. Mayor Huston will contact Alliant Energy to have the lights in Old Settlers Park shut off and see if the crew can get the Christmas light across from the fire station working again.

Water Utilities Discussed: No new business to discuss regarding water utilities. Fire Department Business: Fire Chief Jake Zuercher was present to discuss getting the pumps certified on Engine 762 and Tanker 761. Certification of the pumps will be scheduled. The inoperable condition of the foam ops system on Engine 762 was discussed. It will be scheduled to have the foam system checked out and repaired. Appointment of Fire Chief for the New Virginia Fire Department for 2024 was discussed. Nelson moved, seconded by Galivan to re-appoint Jake Zuercher Fire Chief for the New Virginia Fire Department for 2024. A roll call vote was taken: 4 ayes, 0 nays. Motion carried. Appointment of Assistant Fire Chief for the New Virginia Fire Department was discussed. Nelson moved, seconded by Taylor to re-appoint Mike Bethards Assistant Fire Chief for the New Virginia Fire Department for 2024. A roll call vote was taken: 4 ayes, 0 nays. Motion carried.

**Law Enforcement:** The report summary from the Sheriff's Office for the month of November was reviewed. Deputies received or initiated 25 calls for service during the month of November. Officers spent in excess of 39 hours in the City for the month. Officers patrolled in excess of 248 miles within the city limits for the month. Two citations and/or warnings were written for traffic/parking violations that occurred within the City of New Virginia proper. Sheriff Joe Carico was present to discuss a new Agreement and Contract for law enforcement services. The new Agreement/Contract would lock the rate at the same rate as this fiscal year (\$12,596) for fiscal year 2025, 2026 and 2027. The Agreement will be re-negotiated by the City of New Virginia and the Sheriff prior to the beginning of Fiscal Year 2028. Nelson moved, seconded by Truman to approve a new Agreement and Contract for law enforcement services between the City of New Virginia and the Warren County Sheriff locking in the rate at the same rate as this fiscal year (\$12,596) for fiscal year 2025, 2026 and 2027 by resolution. A roll call vote was taken: 5 ayes, 0 nays. Motion carried. Galivan moved, seconded by Strange to waive a thirty day hearing regarding a new Agreement and Contract for law enforcement services. A roll call vote was taken: 5 ayes, 0 nays. Motion carried.

Taylor moved, seconded by Nelson to open the public hearing to pass and approve Resolution 2023-09 A RESOLUTION DIRECTING THE SALE OF AN INTEREST IN REAL PROPERTY THAT PORTION OF PINE STREET RUNNING NORTH AND SOUTH AND LYING ADJACENT TO AND WEST OF LOT 10, DAVIDSON'S ADDITION TO THE TOWN OF NEW VIRGINIA, WARREN COUNTY, IOWA. A roll call vote was taken: 5 ayes, 0 nays. Motion carried. With no citizens present to approve or disapprove and no written or email responses regarding the proposed selling of the above described portion of Pine Street, Nelson moved, seconded by Taylor to close the public hearing. A roll call vote was taken: 5 ayes, 0 nays. Motion carried.

Taylor moved, seconded by Nelson to pass and approve Resolution 2023-09. A roll call vote was taken: 5 ayes, 0 nays. Motion carried.

Correspondence was received today regarding the draft of the New Virginia Urban Revitalization Plan. Nelson moved, seconded by Galivan to table any further discussion of the New Virginia Urban Revitalization Plan until speaking directly to the company about changes to the draft. A roll call vote was taken: 5 ayes, 0 nays. Motion carried.

Two bids for snow removal from City streets, alleys and sidewalks for the 2023-24 season were received – Bortell Welding & CNC Plasma Cutting bid – 2 units with V-plows, \$100.00 per hour per unit. Huston's bid – same as 2022-23 at \$85.00 per hour. After reviewing and discussing the bids, Nelson moved, seconded by Galivan to approve the Huston bid at \$85.00 per hour. A roll call vote was taken: 5 ayes, 0 nays. Motion carried.

The outdoor movie venue was discussed including the consideration of a car show/drive-in movie night next summer.

#### **GAMP UPDATE**

No GAMP updates for the month. The person interested in cleaning GAMP Community Building has not been contacted yet. This will be done before the January council meeting. The code to get into the building will also be changed.

#### KEEP IOWA BEAUTIFUL PROGRAM

The interested parties for the mural project on the north side of the old hardware store will be reviewed, and an artist will be selected at the December meeting.

The 2024 Calendar will be planned at the December meeting.

Two people are getting licensed to be able to do fireworks for Old Settlers.

Truman moved, seconded by Taylor to approve payment of all City bills. A roll call vote was taken: 5 ayes, 0 nays. Motion carried.

With no further business to come forth, Nelson moved, seconded by Galivan to adjourn the meeting. A roll call vote was taken: 5 ayes, 0 nays. Motion carried. Meeting adjourned at 7:50 p.m. The January council meeting is scheduled for Monday January 8th, 2024, at 7:00 p.m. January meeting date – Monday January 8th, 2024, at 7:00 p.m.

### FARM TRANSITIONS CONFERENCE TO BE HELD IN AMES FEB. 8-9 Learn directly from farm transition and estate planning experts

November 16, 2023, 12:30 pm | Kitt Tovar Jensen

AMES, Iowa – The 2024 Farm Transitions Conference will be held Feb. 8-9 at the Gateway Hotel and Conference Center in Ames.

More than 15 presenters including attorneys, farm management experts and farmers will offer two full days of presentations on a wide variety of topics related to farm transitions and estate planning. The conference theme is "Sowing Success," and the event is hosted by the Beginning Farmer Center at Iowa State University.

The first day, Feb. 8, will focus on transition planning, and the second day will focus on estate planning.

Kitt Tovar Jensen, manager of the Beginning Farmer Center at Iowa State, said the program is designed to help attendees navigate the complexities of a family business and facilitate connection to the various professionals, governmental agencies and agricultural organizations that can offer support.

"The success of your farm depends on your ability to make decisions with the information available to you," she said.

The program is for beginning farmers as well as those looking to transition their farm to the next generation, and also those who simply want to review their current farm transition plans. There will be new content and sessions this year, so even if you attended in the past, plan on learning something new.

#### Topics and sessions

During the estate planning sessions, presenters will talk about the importance of estate planning for all farms and family situations. Topics will include the basics of wills, trusts, the probate process, taxes, farmland appraisals and strategies for communication and mediation.

The second day will also include a discussion with retired farmers Kathy and Caroll Hoksbergen, who will share their personal experiences about farm transitions and journey to find a farm successor.

"I'm really excited to hear from both sides of the process. Speakers include professionals working in this area as well as those who have gone through a farm transition and can speak from personal experience," said Tovar Jensen, who is also a staff attorney with the Center for Agricultural Law and Taxation at Iowa State. "This year's conference will provide practical advice that people can put to use, and hopefully we can help some folks avoid mistakes and family disputes by thinking proactively and constructively."

Both days include time for networking with other attendees and presenters.

"I want to make sure people can connect to the professionals who are here," she said. "I really want people to feel empowered to take the next step in their farming operations after they leave the conference."



## **JESUS' RIGHT HAND**

It has been said that we never quit learning. As we grow and mature, life's lessons may change, but the process of learning never ceases. You would think that the huge moments in our lives are the moments with the most valuable lessons. But many times, God chooses to teach us using the smallest and most ordinary moments in our lives. This week, it was a lesson that I learned through a plant, a pot, and a nice sunny spot.

We have a large window with a deep ledge in David's Room, our newest area of expansion here at Jesus' Right Hand. This window faces the east and seemed kind of empty, so shortly after we officially opened this room, I decided to fill the void with a plant that had recently been given for David's memorial service that week. It was a rather ordinary Peace Lily, but it held some significance in our hearts and seemed to fit rather nicely in that location.

Over the next year and a half, this plant was largely ignored, thriving on neglect and the warm morning rays as the sun came up over the edge of the buildings across the street. Sometimes it would begin to wilt beyond recognition because we forgot to water it on time, but it would always pop back to life within a few hours of receiving a nice, fresh drink. But recently, we noticed that it wasn't looking too good, and some of the leaves had begun to yellow and die. It was just a plant after all, but it held some significance in our hearts, and we just couldn't stand to let it go. I asked a good friend who has a green thumb if she would mind taking it home to nurse it back to health. She showed me photos of her progress and told me that our Peace Lily's problem was that it was root bound. In one photo, all you could see was a mass of white roots that was formed into the shape of the pot in which this plant had been. She explained that she had carefully separated this one plant into sections, untangling roots and repotting it into separate pots. She was going to let these plants sit in the sun for a few weeks to recover and begin to grow anew and would bring them back to us when she felt they were going to be OK in their new living accommodations.

So, this past Tuesday, "Little David" (as this plant was nicknamed) came back to Jesus' Right Hand in four separate pots, beautiful, and healthy and thriving. I'm sure the process of repotting was rather traumatic for him, but in the hands of a skilled gardener, it was necessary, and it saved his life. It did a lot for those of us here at the ministry who have sappy, sentimental hearts.

The life lesson that came to me this morning was that, like this plant, we often become comfortable in our life, sitting in the warm sun in a place where we feel safe and secure. However, as we grow and mature through the years, we too become "root bound," unable to grow beyond the pots in which we have grown comfortable. Then it becomes necessary for the Master Gardener to pull us out of that situation and lovingly and carefully untangle what we have created in our comfort zone. This change isn't pleasant and comes as a shock, but in His infinite wisdom, God knows what is best for us. He puts us in new positions, charges us with new, unfamiliar tasks, prunes and trims things from our lives that are hindering our growth, and often puts us in new environments and living situations that only He knows will cause us to flourish and mature. Change is never easy, but it is necessary and life-sustaining.

However, the real heart of this life lesson came clear when I thought about the effect one of these plants is going to have outside of the walls of Jesus' Right Hand. It will be living on a plant stand in my 90-year-old mother's window, filling an empty spot that was once the home of a plant she had for many, many years. It will remind her every day of the son-in-love she misses so much, and bring her memories of the Godly peace that David carried with him everywhere he went. It's as if this little plant is on a missionary journey of peace to bring comfort and joy to whomever sees it. I don't know what will come of the other two little plants yet. I'm sure the time will come when their roots fill their new pots, and they will need to be divided once again to embark on their new missions of life. Only God knows. But wherever their adventures take them, the love, joy, and beauty they bring will spread far beyond the ledge in the east window of Jesus' Right Hand. For where there was only one, now there are four. And they are healthy, vibrant, and growing wherever they have been planted. This gives us hope in our lives.

I pray you are encouraged by these words. We're here for you in whatever you are facing today. We will be glad to pray with you, hug your neck, or even just listen if you need to talk. We are all just blooming where we have been planted, and we praise God that He has done that.

2 C. fresh cranberries (a 12-oz. pkg.can be used; pie plate will be very full)

½ C. sugar (use a little more if using more than 2 C. cranberries)

½ C. nuts (chopped, walnuts or pecans)

2 eggs

1 C. sugar


1 C. flour

½ C. margarine (melted)

<sup>1</sup>/<sub>4</sub> C. shortening (melted)

Grease 10-inch pie plate. Rinse and sort cranberries. Spread cranberries over bottom of pie plate. Sprinkle ½ C. sugar (or more) and ½ C. nuts over cranberries. In separate bowl, beat eggs well and add 1 C. sugar. Beat until thoroughly mixed. Add flour, margarine and shortening. Beat well. Pour the batter over cranberries and nuts. Spread evenly. Bake at 325° for 45-50 minutes until crust is golden brown.
